**In Review Application No. EN 04 of 2022** filed by Dr. D.Y. Patil School of Engineering & Tchnology, Lohgaon, Pune (EN6786) .

It is contended that the disallowances made by the Authority that 50 excess teaching staff was employed by the Institution needs to be reconsidered. It is submitted that 63 teaching staff has left during the academic year 2019-2020. Inadvertantely, the date of leaving the job by those 63 teaching staff remained to be mentioned in the proposal. Due to this reason the Authority has disallowed the salary of 50 staff members as an excess staff. It is further submitted that as 63 teaching staff left the job the Institution was required to employ the visiting faculty.

The Officials are directed to file affidavit in support of oral submission made during the course of hearing and produce the documents with list of teaching staff regisned with date of regisnation of teaching staff & copies of their resignation letters. Also file list of visiting faculties with their names, educational



qualification, payment & mode of payment. The affidavit to this effect with the documents be filed on and before 10/05/2022.

List the Review Application for further hearing on 10/05/2022.

Follow up action be taken accordingly".
